In light of these considerations, Conekt Gadgets LLP hereby announces its intention to sell the service liability associated with our brand's warranty products. Scope of Work:

As the supplier of the aforementioned products to government entities through successful bidders, Conekt Gadgets LLP acknowledges its responsibility to honor warranty claims in accordance with the terms specified in the respective tenders.

To facilitate potential bidders in making informed decisions, we are committed to providing samples of the products listed above. These samples will be made available for testing purposes, allowing bidders to assess the quality and longevity of the products firsthand.

Furthermore, Conekt Gadgets LLP recognizes the importance of transparency and fairness in the tender process. To this end, bidders who have successfully paid a non-refundable tender document fee of Rs. 10,000/- are entitled to access all relevant tender documents and product samples at our office. Payment for the tender document fee can be made via cheque or demand draft issued in the name of Conekt Gadgets LLP.

It is our expectation that potential bidders will thoroughly evaluate the samples provided and familiarize themselves with the tender documents before submitting their bids. This ensures a level playing field for all participants and promotes confidence in the integrity of the tender process.

Evaluation Criteria:

The evaluation of bids will be based on the following criteria:

- 1. **Price:** (Weightage: 70%)
 - 70% of the total score will be allocated based on the lowest bidded price submitted by the bidder.
- 2. **Promoter Experience:** (Weightage: 15%)
 - 15% of the total score will be allocated based on the promoter's experience as a trader, wholesaler, distributor, or service provider in a similar line of items. This includes expertise in handling and servicing electronic products.
- 3. **Company Turnover:** (Weightage: 10%)
 - 10% of the total score will be allocated based on the turnover of the bidding company as a trader, wholesaler, distributor, or service provider in a similar line of

items. This reflects the financial stability and capability of the company to fulfill its obligations.

Contract Terms:

- 1. **Bidding Process:** The bidding process must encompass all items listed together, and no conditional bids will be accepted.
- 2. **Procurement of Parts or Products:** In the event of servicing, which may involve replacement of parts or total replacement of products, the bidder has the flexibility to procure the required components or products either from Conekt Gadgets LLP or from the open market, irrespective of the brand. The bidder's decision regarding the source of the parts or products shall be final and binding in this matter.
- 3. **Indemnification:** Additionally, the bidder agrees to indemnify Conekt Gadgets LLP across all legal matters and compliances, including but not limited to GST, Income Tax, or any other related departments. The bidder shall attend to any such matters as and when requested by Conekt Gadgets LLP in such scenarios.
- 4. **Arbitration:** Any disputes arising from this agreement shall be resolved via arbitration conducted by a retired magistrate, mutually agreed upon by both parties. The arbitration process shall strictly adhere to the terms and conditions outlined in this agreement.

Payment Terms:

Payment for the contracted services will be divided into three installments. The final invoice will be raised with mutual consent within six months of signing the agreement. Each installment shall be payable within five months from the date of invoicing, contingent upon the availability of funds in the company.

Confidentiality:

Given the direct impact on brand image, the data related to replacements is deemed highly confidential. Under no circumstances should this information be shared with any individual or entity unless demanded by a judicial order.

The bidder is responsible for safeguarding this information and must implement stringent measures to ensure its protection. Furthermore, precautions should be taken to prevent any estimation based on individual pick-up points or service centers.

Documents Required for Technical Stage:

To proceed to the technical stage of the bidding process, bidders are required to submit the following documents:

- 1. Owner's Aadhar and PAN Copy.
- 2. Company Address Proof, GST Certificate, PAN Card.
- 3. Three years' Balance Sheets.
- 4. Three years' Income Tax Returns.
